Meeting called to order by Chair Henderson at 2:03 p.m.

Public Comments

None Public comment was made available live and with a posted email address Minutes Approval

Mayor Silvestrini moved to approve the minutes from the November 29, 2023 Finance Committee Meeting as submitted

Council Member Buroker seconded the motion All voted in favor, none opposed

Budget Message - Chief Burchett

- Chief Burchett reviewed his budget document in this first presentation of the FY24/25 budget
 - There is a Finance Committee Meeting scheduled for 5/7
 - At this meeting, each Division will present their budget and answer any questions
 - The Benefits & Compensation Committee's final recommendation was for sworn market adjustments to achieve at least 3% below the current Top 3 in each position, 3% COLA for all employees, updating 26 civilian positions that were out of market, and a 5.37% renewal rate from SelectHealth
 - All sworn position comparisons and recommended adjustments are included in the budget document for review
 - Chief Burchett noted that the General Fund percentage breakdowns are almost identical to last year between personnel and non-personnel
 - There is a proposal to capture \$372,000 for one-time purchases from fund balance
 - This is for items that do not fit categorically into operating budgets for capital replacement
 - Chief reviewed the items included in this one-time purchase, which included extended warranties for Zoll heart monitors and new MDT devices
 - Mayor Weichers questioned the value of these extended warranties
 - Chief replied that the hope is to get another year or two before having to replace the heart monitors
 - When they break, we ship them out & they send another
 - They are identified in capital plan, but the goal is to try to get life out of them as they are very expensive machines
 - The same is applied to the MDT devices (computers), the hope is to get extended use from them before needing to replace
 - Council Member Henderson asked to see some data on cost benefit and replacement costs for the next meeting on 5/7
 - Chief Burchett then reviewed the key budget impacts
 - There are inflationary costs on pretty much everything
 - A table was provided with the main impacts highlighting both costs and cut saving measures
 - A stress test was also conducted resulting in a \$249,553 cost savings throughout all Divisions
 - In answer to a question from Council Member Buroker, Chief explained the role of the Behavioral Health Manager that is currently funded with grant monies
 - The Capital Replacement Fund was reviewed
 - Chief pointed out what is being done in order to prepare for a small lease FY25/26 roll off, resulting in replacement with a larger debt service payment
 - Council Member Henderson lauded these forward thinking efforts to prepare for these new costs and the need for additional funding
 - A digital copy of the budget book will be distributed to all Board Members as well
