1. Call to Order

Quorum present

Chair Weichers called the meeting to order at 7:30 a.m.

Chair Weichers welcomed new Board Member Millcreek Council Member Cheri Jackson who will be replacing Mayor Silvestrini

Chair Weichers reminded all Board Members that there will be a Public Hearing tonight at 6:00 p.m. to discuss fee increases

2. Public Comment

- Council Member Harris thanked UFA crews at Station 119 for their quick response on a fire in Emigration Canyon
- A public comment was sent via email and forwarded to the Board, as it was past the submittal period, it was not addressed at the meeting or read into the meeting record

3. Approval of Minutes

9. Consider Request to Approve the Rollover of Funding for Two FY24/25 Projects

- Chief Burchett reviewed the memo explaining that there were two projects staff was unable to accomplish
- The request to the Board is to roll over the funds to allow the projects to be completed this coming year
- The first project is the replacement of the Flashover Prop at the Fire Training grounds that is at it's end of life, \$130,000
- The second project is the funding for professional development, \$20,000
 - An annual training for new and upcoming leadership was budgeted for, but due to internal scheduling conflicts, was unable to be scheduled
 - Rolling over the funding for this project will result in two opportunities for professional development this coming year
 - Both the CenterPoint cohort and another training offered by Mission Centered Solutions will provide professional development opportunities for administrative and operations personnel

- CFO Hill noted that the final exhibits are pay plans and benefits that have been vetted through both the Benefits & Compensation Committee and the UFA Finance Committee

12. Administration & Planning Report

- Administrative & Planning Overview
 - AC Russell has been conducting a comprehensive review of the structure of all internal committees
 - The intent is to ensure all committees have goals and are running efficiently
 - This should translate into actionable outcomes and increased oversight
 - Professional development opportunities are also at the forefront of his focus
 - The Liaison Program is being reviewed to provide more consistent messaging, mentorship, efficiencies, and effectiveness, while ensuring the program is sustainable

- There will be some restructuring and realignment within the program
- These changes will be presented at the upcoming CFO/City Manager Meeting, 6/24
- More information will be discussed at the July 15 Board Meeting

13. Operations Report

- AC Dern presented the report from last month
 - Incidents are at 16,000 YTD
 - Just over 3,300 for May, up 255 from 2024
 - UFA is trending at about 1,000 more calls per calendar year, this is being closely tracked
 - Council Member Fotheringham inquired as to what could be attributed to the increase
 - AC Dern replied that possibly growth and more population density could be contributing to the increase
 - Within the 2025/2026 budget, the trial run of a Low Acuity unit may help to buffer the use of the larger apparatus on non-emergent calls
 - Council Member Buroker asked if fires from lithium batteries are identifiable, to which AC Dern replied that through the fire investigation the cause would be tracked
 - Council Member Buroker hoped that the cause would circle back to media posts or some sort of preventive message
 - AC Dern stated that yes, this would be addressed through Community Risk Reduction outreach
 - Council Member Buroker asked about the incidents wherein crews were dispatched but cancelled enroute and what is done with this information
 - When dispatched and cancelled, there are many categories of calls
 - We have identified and are working on properly categorizing this category of calls
 - AC Dern expects that with the current work taking place in these instances, the number of these calls will decrease in future reports
 - Council Member Buroker feels it would be valuable if staff was able to calculate the cost every time this happens and use this information as education for the public with the hope that public awareness reduces the number of calls
- Holiday Staffing
 - With the upcoming July holidays, UFA will upstaff three Type 6 and one water tender from noon until midnight July 4
 - The fuels crew and Camp Williams personnel will also be available
 - Historically crews are busier with vegetation fires and medical calls, this upstaffing has been valuable in managing the additional calls and containing fires quickly
 - Staffing will be reevaluated prior to the 24th holiday
- Swift Water Incident
 - AC Dern reviewed an incident near the mouth of BCC involving an adult stranded in the creek
 - Due to the water conditions, crews decided a traditional water rescue was a risk
 - Aerial apparatus was used to lower a rescuer to the individual using a rope system and safely pulled the individual out of danger
- Operations Chief Nathan Kay
 - AC Dern introduced the new Operations Chief, the position vacated by AC Russell

14. Fire Chief Report

- Hot Shot Status – DC Widdison
 - Division Chief Widdison provided an overview of the 2-day interagency evaluation process
 - Apparatus, a sand table exercise, administrative documents, and a field exercise were all part of the testing
 - It was decided to not certify the crew at this time

- UFA understood this would be a challenging process, however this outcome is disheartening as work has been ongoing for the past 5-years to meet the national standards
- Work is being done to seek additional clarification of what needs to be done to meet the standards
- UFA is proud of the crews and the UFA Board's continued support
- Council Member Buroker asked how soon UFA can reapply and what is the course of action
 - DC Widdison stated that this is an unknown and that the certification team didn't know either
 - To this point, no one has been able to communicate what needs improvement and this has now been taken for review to a higher level with the hope of getting some clarified guidance
- Council Member Harris has been following this process for years and is proud of the crew
- DC Widdison noted that the crew has been deployed to a fire in Wyoming
- Chief Burchett pointed out that only two other crews have attempted this certification in the past 10-15 years with the three levels of bureaucracy
 - UFA will continue working with the coordination group to explore the next steps
 - This is a setback, but will be used as an opportunity to improve, we will not give up
- Chief Burchett acknowledges the amount of work that has been done and the great leadership given to the crew, they are ready and will continue to pursue Hot Shot status
- Information Outreach Event Season – Captain Barker
 - Captain Barker provided an overview of the upcoming events
 - On duty crews will attend events pending 911 response needs
 - Mayor Gettel discussed informing the community of when to call 911 and when to not
 - Captain Barker clarified that early activation of a response for a fire is paramount
 - Mayor Overson thanked Captain Barker for his expertise during the Taylorsville Dayzz planning meetings and for voicing vulnerability and safety issues
- UFA Board Elections
 - Chief Burchett reminded Board Members that Chair Weichers agreed to remain as Chair through the budget process and will now be stepping down
 - Please reach out to Mayor Weichers or Chief Burchett if interested in serving as Vice Chair
 - Council Member Fotheringham is currently serving as Vice Chair with the intent to advance to Chair for the coming two years
 - Also noted is that the Chair for Benefits & Compensation will need to be elected at the next Benefits & Compensation Committee Meeting
 - Elections will take place at the July 15, 2025 Board Meeting
- Executive Assistant Position
 - Chief Burchett introduced Micayla Dinkel who will be replacing Cyndee Young following her retirement in July
- Olympic Preparations
 - Chief Burchett intends to get ahead of the planning process for the Olympics
 - Work has begun to identify funding, grants, staffing, and resources that will be needed
 - A review of the impact to the organization and funds that were available during the 2002 has begun as well
 - Chief Burchett wants to make sure that UFA is in the position to be successful
 - If any Board Members hear of any funding opportunities, please reach out
 - Council Member Hull asked about venues within the service district
 - Chief Burchett replied that what venues will be used is still unknown

Proposed Realignment of UFA Liaison Program

Highlights and Summary

Unified Fire Authority (UFA) is Utah's largest fire service, providing emergency services to 15 municipalities and the unincorporated areas of Salt Lake County. Maintaining strong relationships with each of these communities is vital to UFA's mission. Currently, UFA assigns either a Battalion/Division Chief or a station Captain to serve as the city liaison, acting as the primary representative to local elected officials and administrative staff. These liaisons attend city council meetings, provide department updates, and coordinate with city staff on community risk reduction and emergency planning initiatives.

In recent years, UFA has successfully transitioned most city liaison roles to chief officers, with 13 of 15 municipalities currently represented by a Battalion/Division Chief. This structure has demonstrated clear benefits in responsiveness, authority, and strategic coordination. The intent of this realignment is to complete that transition by assigning a Battalion/Division Chief as the official liaison in all municipalities, creating a unified and consistent model of executive representation across the entire service area.

UFA leadership has long emphasized the importance of the liaison program in building community trust and ensuring municipal engagement. Strategic plans call for enhancing the visibility and availability of UFA's leadership to local government partners. A 2020 survey of city leaders reinforced this commitment, with over 91% of municipal stakeholders expressing satisfaction with the responsiveness of their UFA liaison.

To build on this success, UFA is formalizing a realignment of the liaison structure that ensures all municipalities are assigned a chief officer liaison, supported by increased involvement from the Assistant Chiefs. This model strengthens city level representation, improves intergovernmental communication, and reinforces UFA's dedication to each of the communities it serves.

Proposal

Outlined in this document is a proposed realignment of the UFA liaison program. The goal is to enhance community engagement and executive visibility by ensuring that each of UFA's 15 municipalities is assigned a chief officer to serve as liaison. It establishes a leadership framework that supports strategic communication, intergovernmental coordination, and a strong connection between UFA leadership and its member communities.

Proposed Realignment of UFA Liaison Program

Executive Presence at City Council Meetings: In addition to the day-to-day liaison work done by the Battalion/Division Chiefs, each Assistant Chief will personally attend a city council meeting in one of their municipalities each month on a rotating basis. This means that every month, each Assistant Chief will be present at a different city council meeting within their region. The purpose is to support the Battalion/Division Chief liaison and to formally represent the Office of the Fire Chief at important public forums. By having an executive chief officer periodically present at council meetings, UFA demonstrates its commitment to the partnership with that city's leaders. The Assistant Chief can address high-level questions or policy matters, convey UFA's strategic initiatives, and show accountability directly to elected officials. This regular executive attendance complements the Battalion/Division Chiefs ongoing liaison efforts and visibly connects UFA's top leadership with the communities served.

New Roles and Responsibilities: Under this model, the responsibilities will shift as follows. Battalion/Division Chiefs will take on the liaison duties that Captains performed in the past, becoming the "face" of UFA in their assigned city and managing all routine communications with city officials. The Assistant Chiefs will add a new

layer of involvement in municipal relations. They will mentor and direct their Battalion/Division Chief liaisons and ensure that UFA's Office of the Fire Chief remains highly visible and responsive across all jurisdictions. This structure creates a clear hierarchy for municipal communication, and city concerns can be handled at the appropriate level (Battalion/Division Chief or escalated to Assistant Chief), and information will flow efficiently between city halls and UFA leadership.

Rationale for the Change

To ensure long-term sustainability and improve consistency across jurisdictions, UFA is realigning the liaison program to better integrate executive oversight, standardize communication, and enhance city engagement. The proposed realignment is driven by the desire to strengthen relationships with communities and to enhance the overall effectiveness of the liaison program.

Several key benefits support this change:

- **Stronger Representation for Cities:** Assigning a Battalion/Division Chief as the city liaison elevates the rank and experience of UFA's representative to the municipality. A Battalion/Division Chief typically has a wide scope of authority and understanding of UFA operations. They can speak to city-wide service issues (spanning multiple stations or battalions) and make decisions or commitments on behalf of UFA with more authority. Cities will have a senior officer advocating for their needs. This change also instills confidence that any concerns raised by local officials will be addressed at the appropriate management level without needing to "work up the chain." In short, municipalities gain more direct access to UFA's leadership through their Battalion/Division Chief liaison.
- **Improved Consistency and Oversight:** By grouping five municipalities under each Assistant Chief, UFA can ensure more consistent communication and service delivery across communities. The Assistant Chiefs will coordinate the efforts of the Battalion/Division Chiefs, standardize messaging (so all cities receive the same information about UFA initiatives, budget impacts, service changes, etc.), and share best practices. This oversight helps to ensure that the liaison program is not just 15 separate relationships, but a unified outreach strategy managed at the executive level. It addresses a strategic goal of making UFA more available and responsive to city administrations. It will also solidify relationships across all jurisdictions by having defined leadership channels.
- **Enhanced Executive Engagement:** Introducing a regular presence of Assistant Chiefs at city council meetings bridges the gap between UFA's executive leadership and local governments. While survey data showed that an overwhelming majority of local officials find UFA's current liaisons responsive, they were somewhat less certain about direct responsiveness from top leadership. This initiative directly tackles that gap by putting Assistant Chiefs in front of city councils on a routine basis. City leaders will have face-to-face interactions with UFA executives. This visibility and personal interaction are likely to increase trust and satisfaction with UFA leadership. It demonstrates to elected officials that UFA's chief officers care about each community's needs and are willing to invest time to attend meetings and listen in person. In turn, the Fire Chief gains additional insight into local issues via the Assistant Chiefs' reports, enabling proactive adjustments to services or resources.
- **Alignment with Best Practices:** The realigned structure mirrors successful models used by other large fire authorities. In regional agencies that serve multiple cities, it's common for an Assistant Chief to act as liaison for a group of municipalities. This approach has proven effective in maintaining consistent service levels and communication across a broad service area. Adopting a similar model at UFA helps ensure the agency keeps pace with modern governance practices and expectations of member

communities. It formalizes the liaison program's importance by making it a defined part of the Assistant Chiefs' and Battalion/Division Chiefs' duties.

In summary, the change is expected to deepen relationships with cities, improve information flow up and down the chain of command, and position UFA to be even more responsive and proactive in addressing local needs. The presence of higher-ranking officers in liaison roles underscores UFA's dedication to its communities and aligns with its mission to protect and strengthen those communities through professional service and engagement.

Transition Plan for Implementation

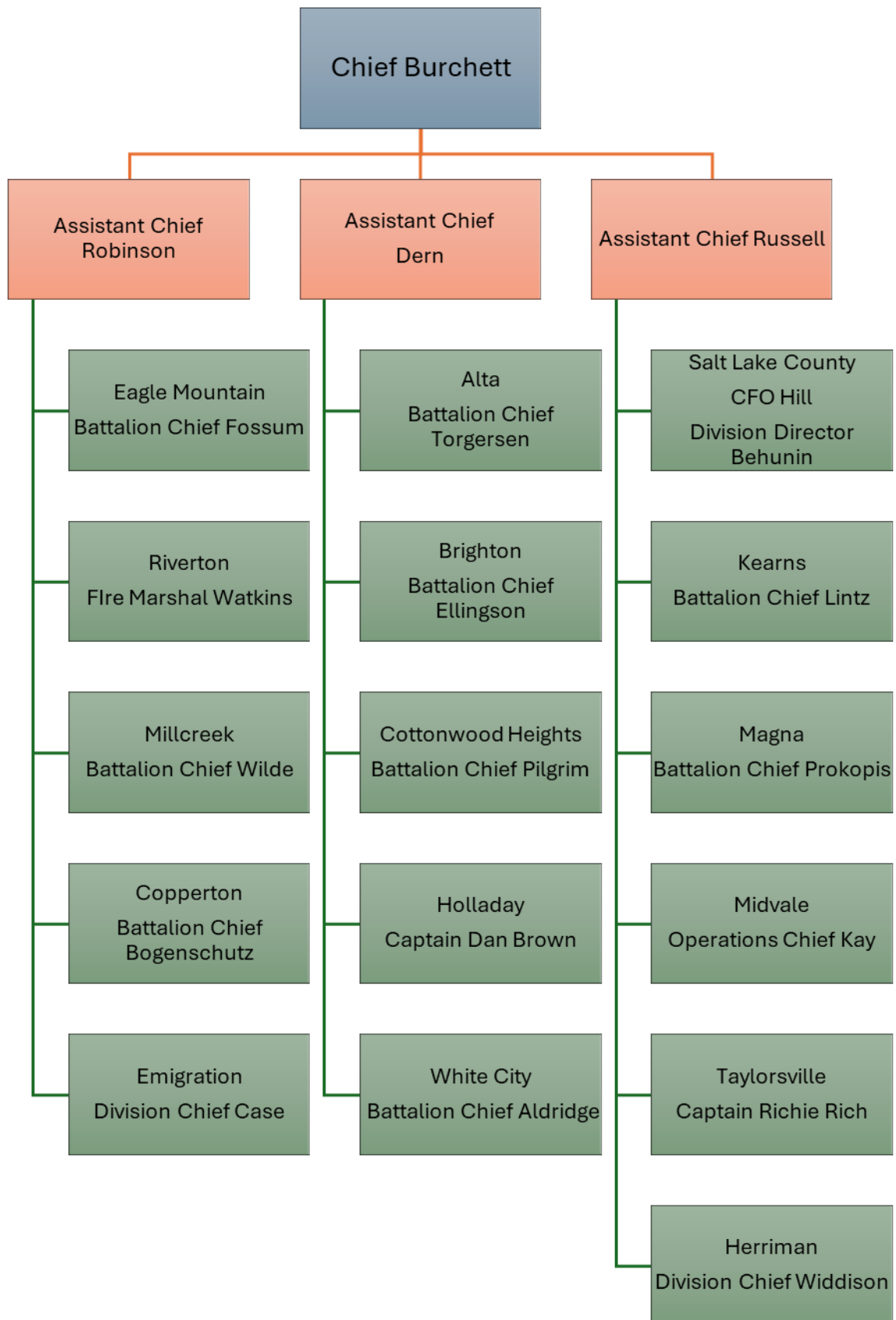
Leadership Support and Communication: Secure approval and support from UFA leadership (Fire Chief and Board of Directors) for the liaison program realignment. Communicate the upcoming changes internally to all ranks, especially the current Captains and Battalion/Division Chiefs, explaining the new structure, reasons for the change, and expected benefits. Also notify external stakeholders, such as city managers and mayors, that UFA is enhancing its liaison program so they are aware of potential changes in their primary contacts.

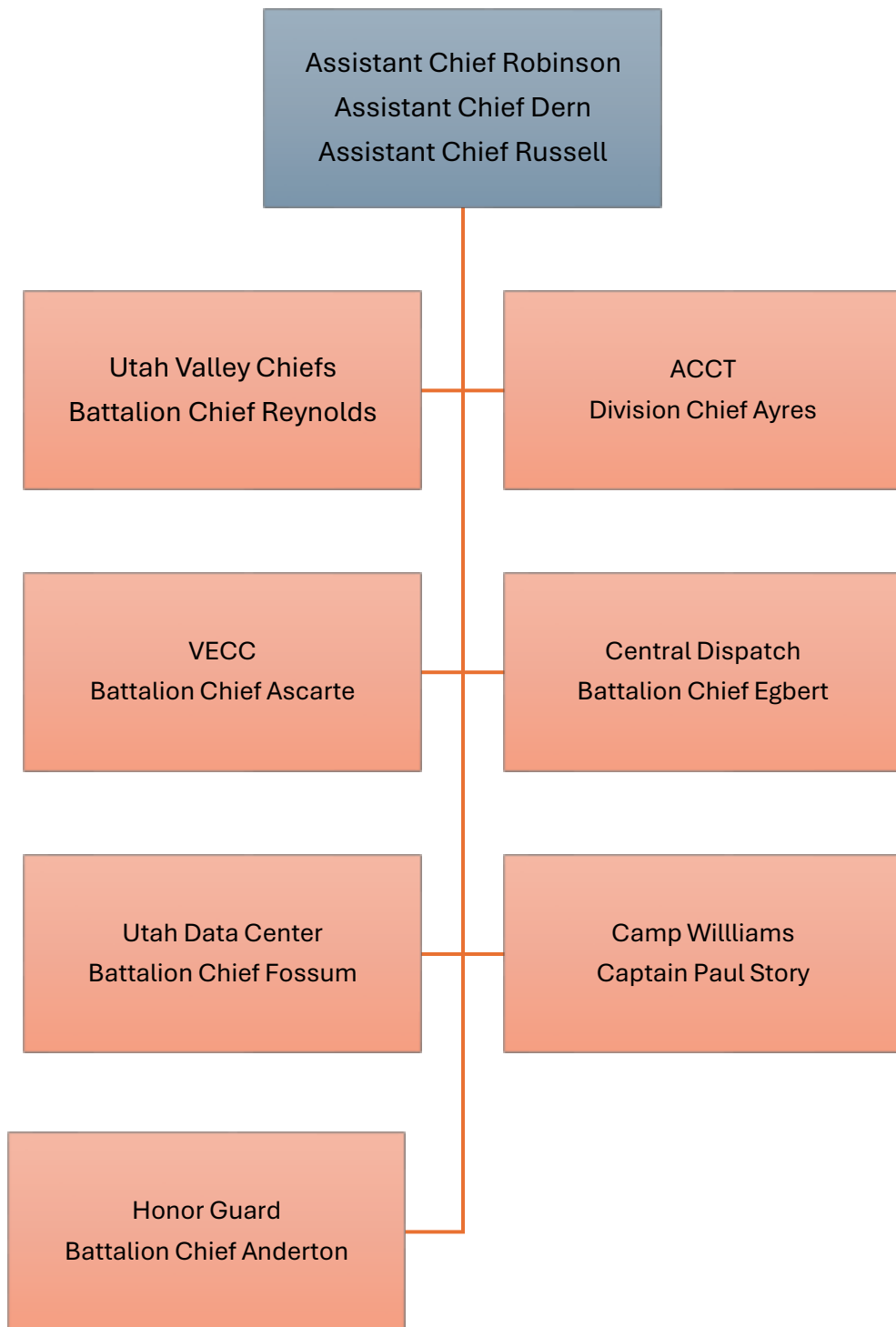
Assign Battalion/Division Chief Liaisons to Cities: Develop an assignment list matching each of the 15 municipalities to a specific Battalion/Division Chief. This may consider current battalion coverage areas, existing relationships, and workload balance. In many cases, the Battalion/Division Chief already responsible for emergency operations in a geographic area can be assigned to the city within that area. Publish a list of the new liaisons with their contact information and provide it to each city's leadership.

Define Assistant Chief Regional Oversight: Determine how the 15 communities will be grouped into three regions under the Assistant Chiefs. Clearly identify which cities fall under each Assistant Chief's responsibility. Communicate these groupings internally and to city leaders so everyone knows which Assistant Chief is linked to their municipality.

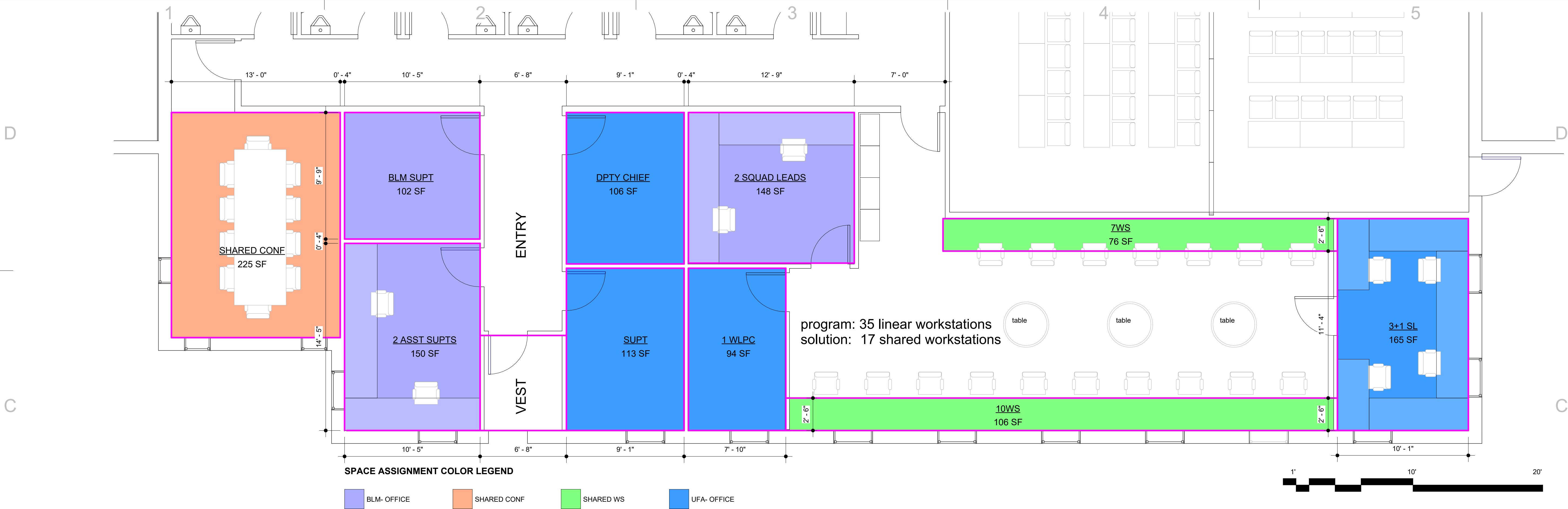
Update Policies and Documentation: Revise any internal policies, organizational charts, or job descriptions to reflect the new liaison structure. The liaison program should be documented as an official duty of Battalion/Division Chiefs and Assistant Chiefs. Additionally, update UFA's website and any public-facing materials to list the new liaisons for each municipality.

By following this plan, UFA can implement the liaison realignment with minimal disruption. With the Battalion/Division Chiefs and Assistant Chiefs in these roles, UFA is positioned to provide an even higher level of service and partnership to each municipality it serves. The realigned liaison program supports UFA's mission to save lives and protect property while strengthening community relationships.

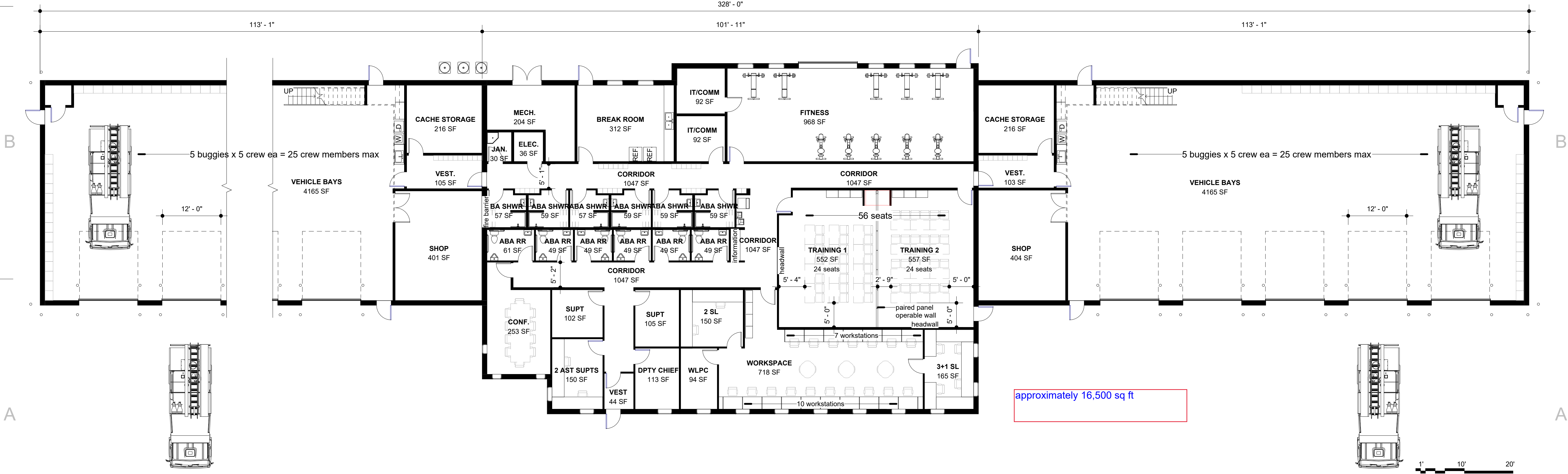

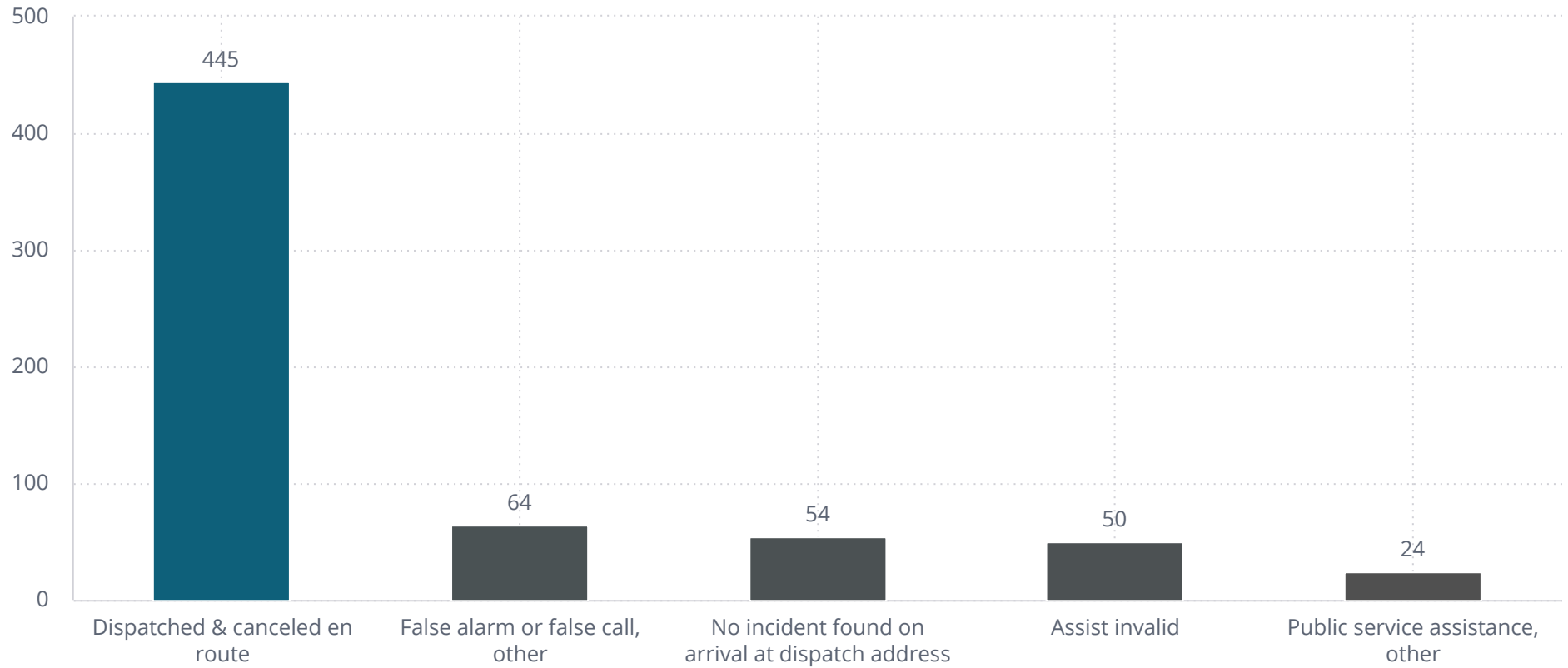

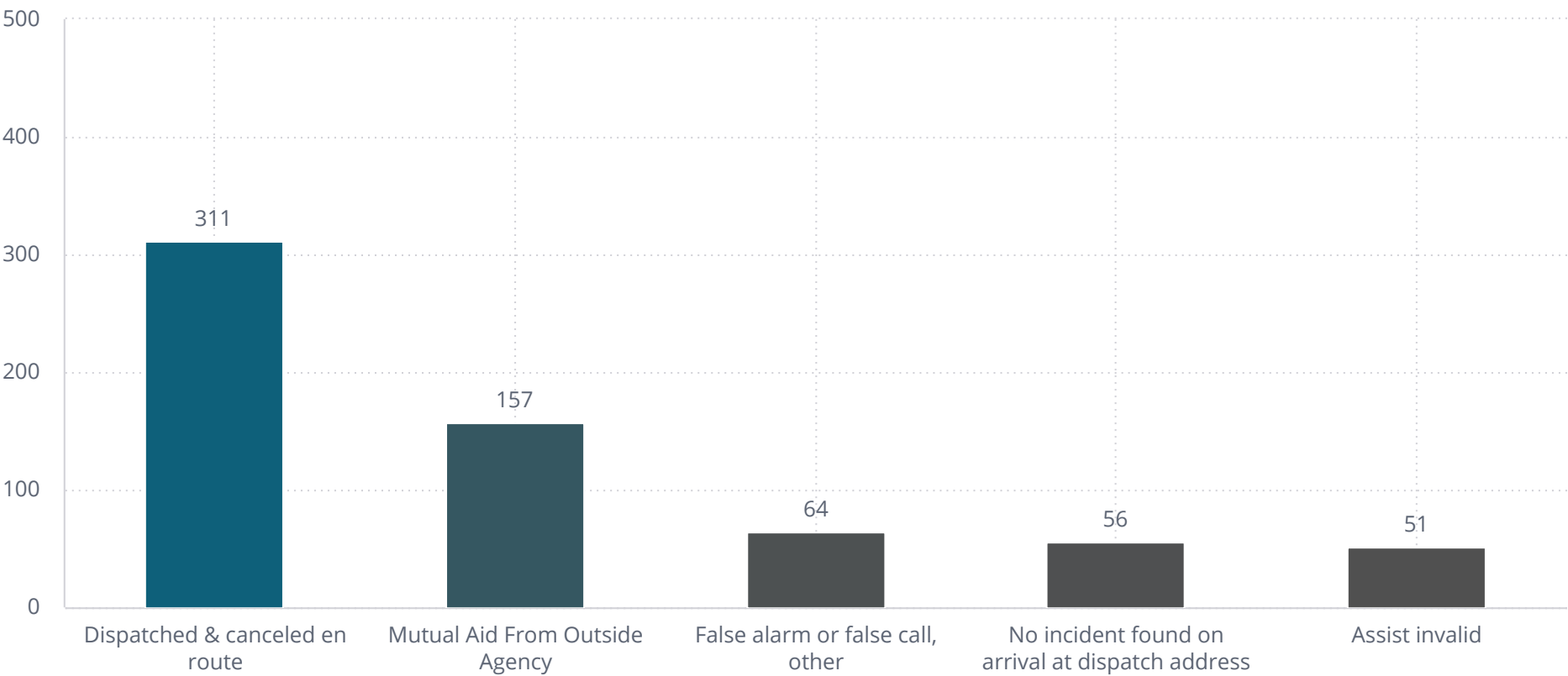

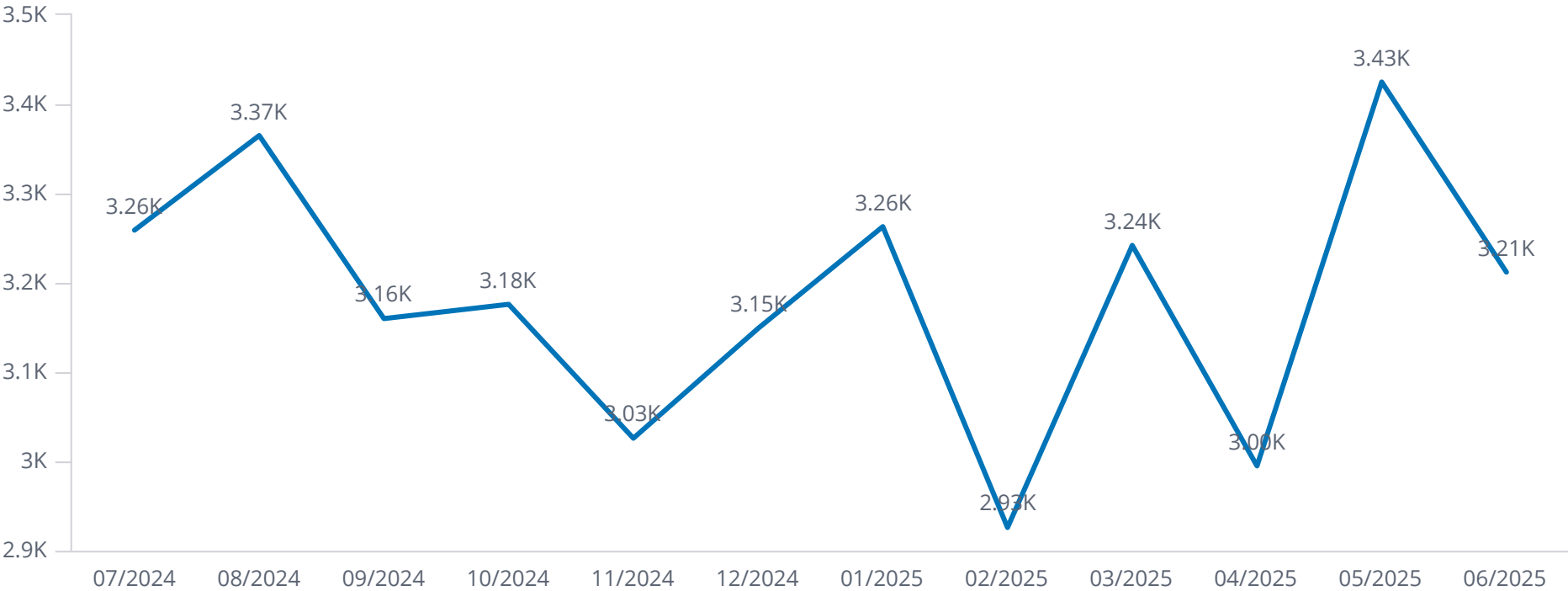

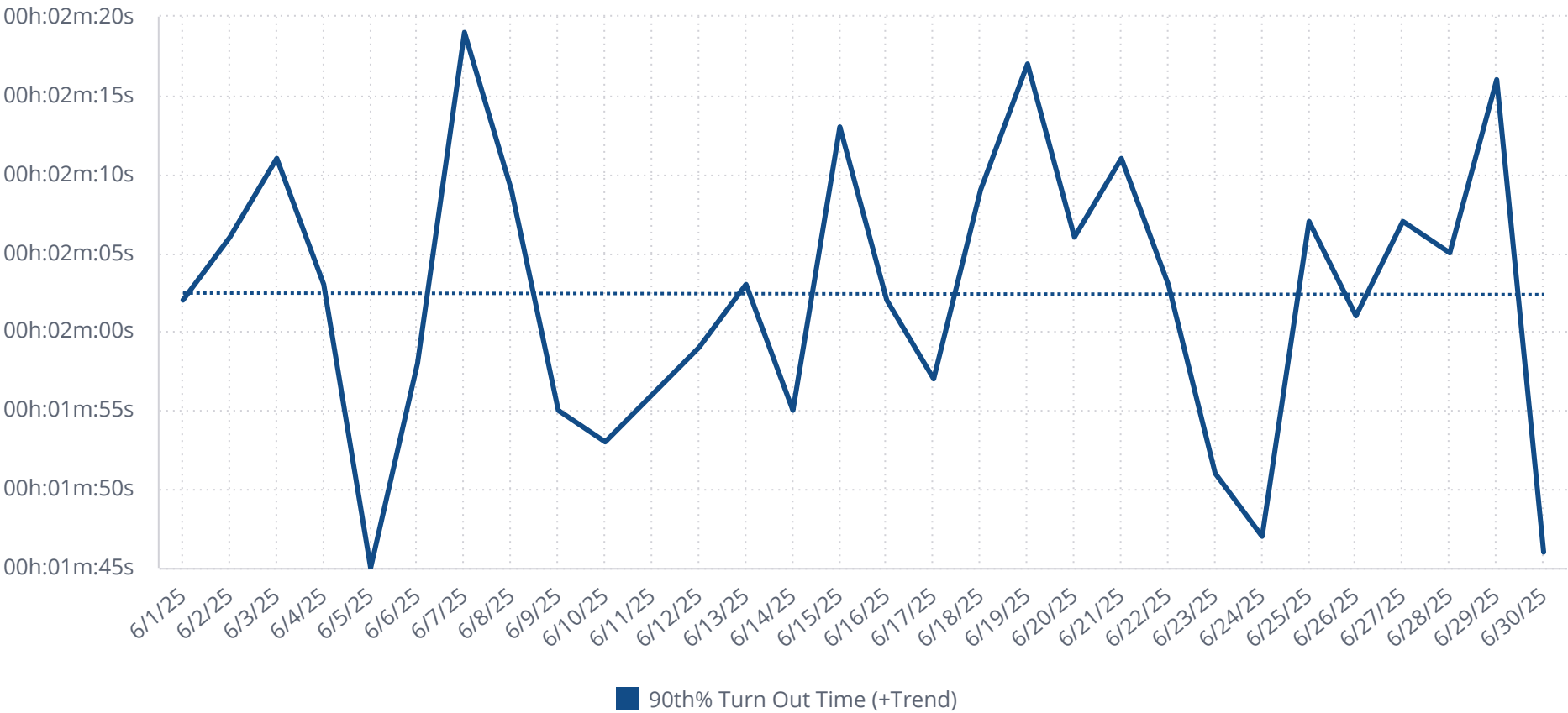

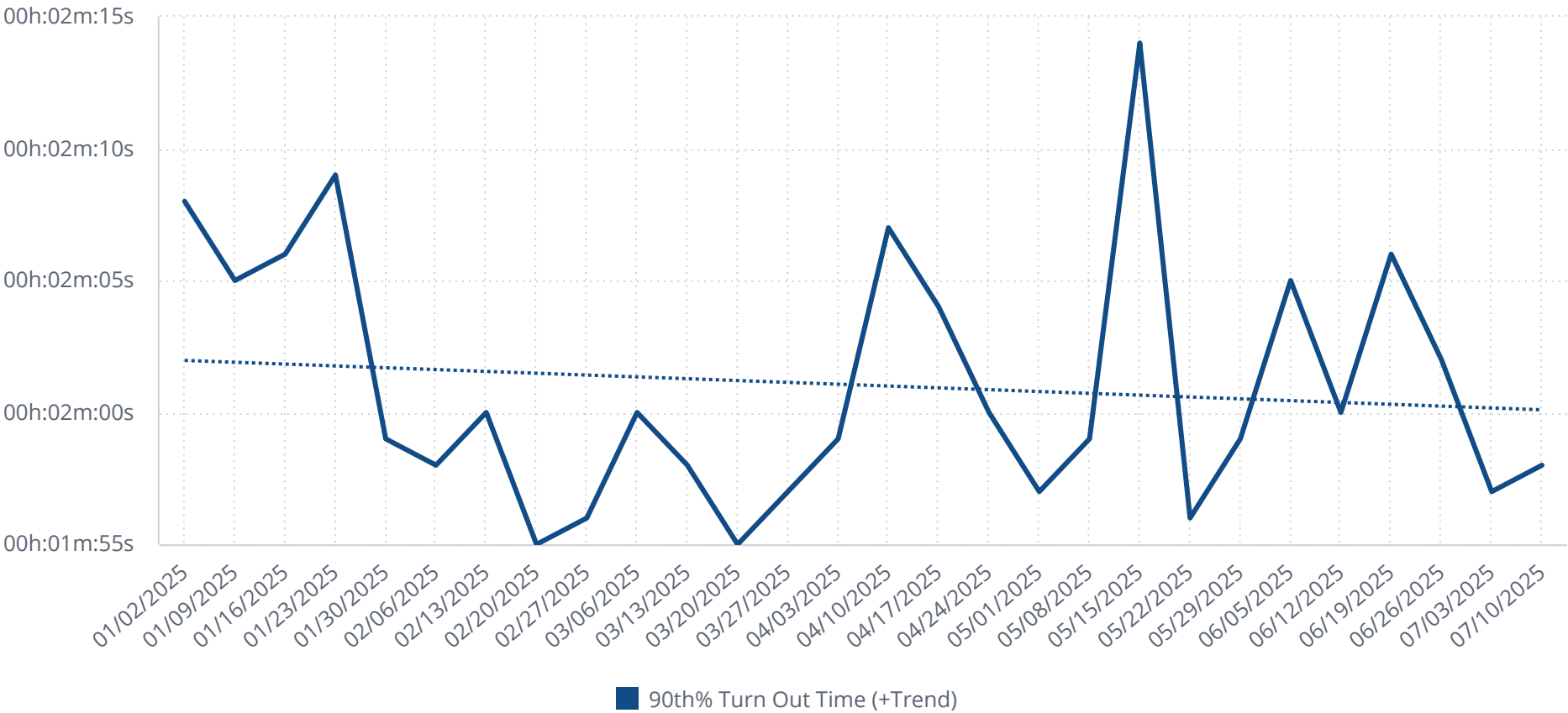

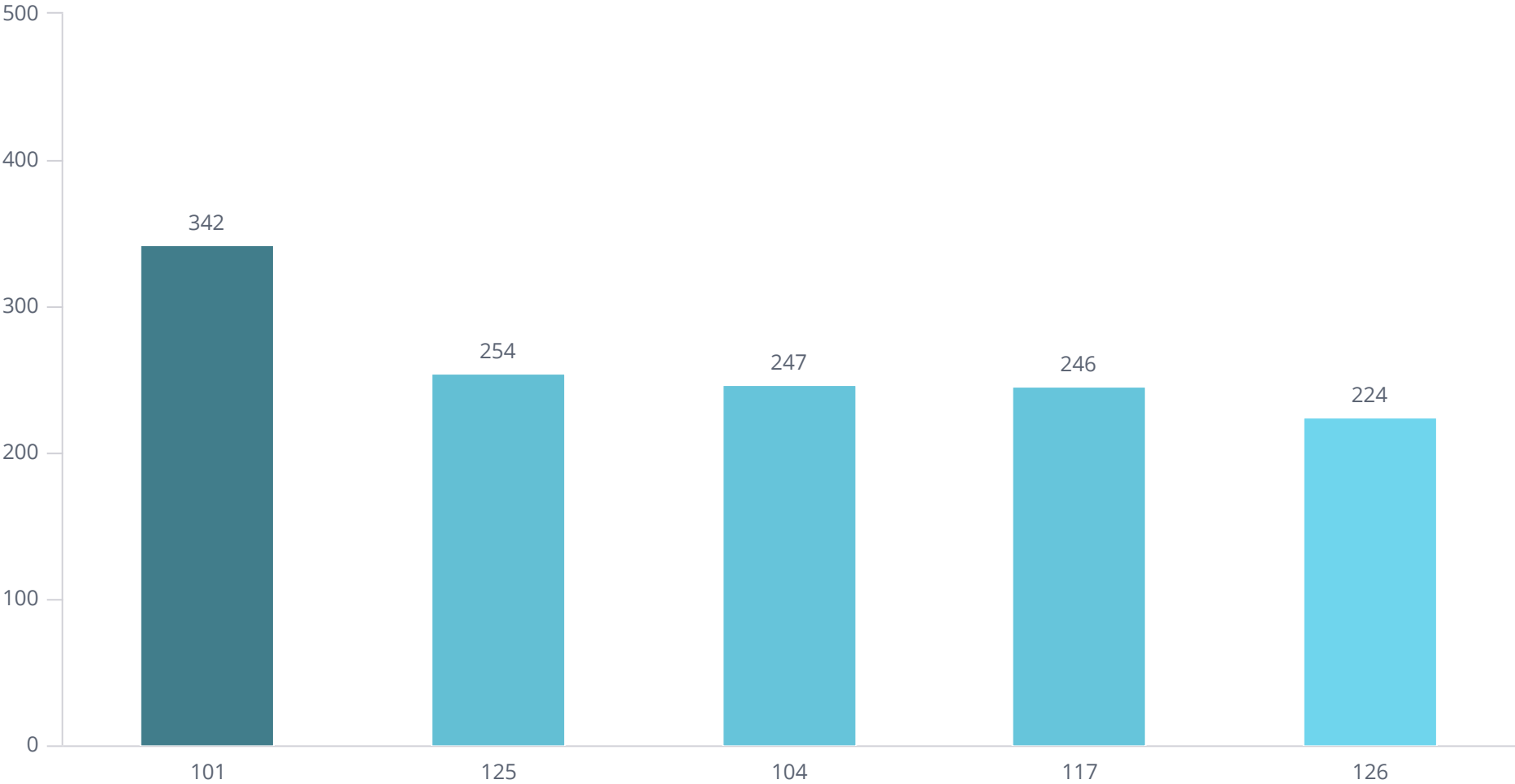

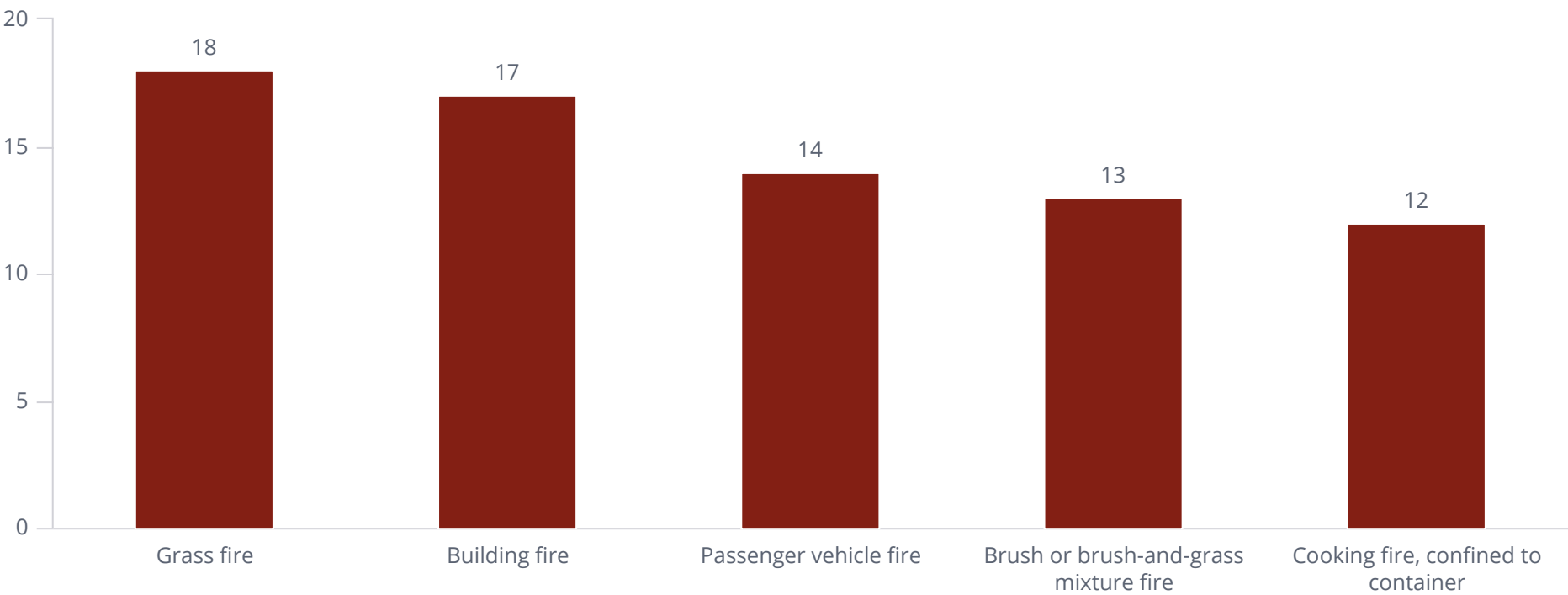

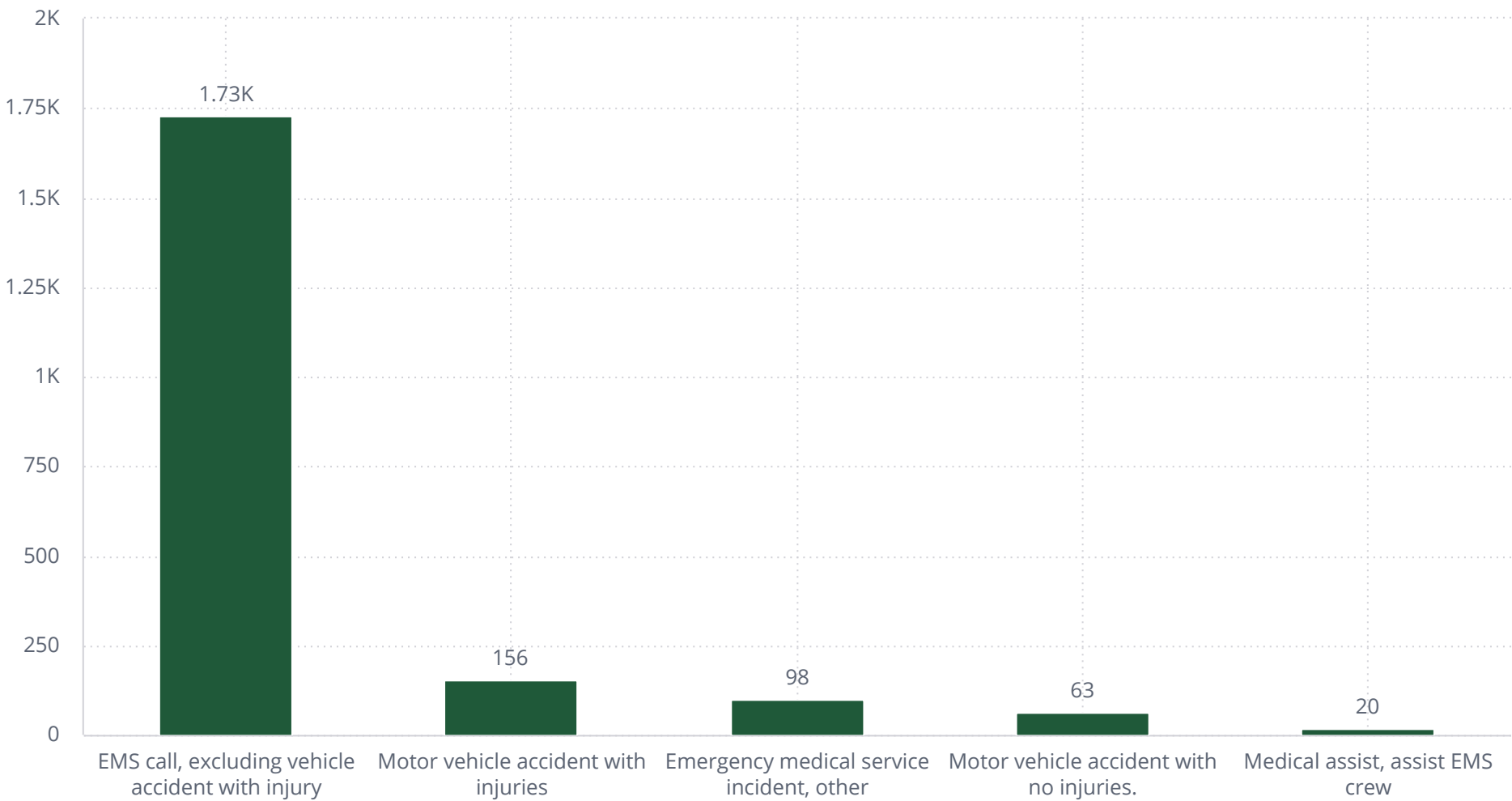
Busiest Station Top 5
